

Introducing New D.C. Partner Morgan Ratner

She knew the Firm's existing client base gave it strong growth potential. But more importantly, she was looking for a firm that was making concrete steps with regard to gender representation.

That drew her to S&C's Washington, D.C., office. Led by Managing Partner Amanda Davidoff, with an impressive roster of litigators and gender parity among its partners, Morgan knew it was the right fit.

Before joining S&C in late 2021, Morgan served in the Office of the Solicitor General at the U.S. Department of Justice and clerked for two sitting U.S. Supreme Court justices.

In fall 2022, she was asked by the Court to defend the U.S. Court of Appeals for the Eighth Circuit's rationale in a habeas case. Morgan collaborated with a majority-women associate team that was involved in every stage of drafting and moot court prep ahead of the argument.

Though it was Morgan's ninth time arguing before the Court, she was still in awe.

"At the lectern, you stand extremely close to the justices. And they do truly want to have a conversation. So when they ask you about constitutional issues or what a statute means, it feels surreal that they are looking to you to shed some light on the case."

Morgan is excited to leverage that first-hand experience as S&C continues to grow its appellate practice, while also using it to mentor young associates. "I think it's important to combine a structural mentorship with an organic working mentorship," she says.

Q&A with Sergio Galvis, General Practice Partner and Head of Legal Recruiting

You have been the head of recruiting at S&C for more than a decade and during that time, you have hired more than a thousand new lawyers, including a significant number of judicial clerks. Can you tell us a little bit about the Firm's recruiting philosophy?

Throughout our history, S&C has been a leader in the practice of law, and our fundamental recruiting philosophy has always been the same: Hire the best and brightest law students and judicial clerks, give them as much responsibility as possible early on in their careers, and develop them into well-rounded professionals who can solve our clients' most complex problems. Recruiting talented law students and clerks to join S&C is—and always has been—central to the health and long-term success of the Firm. Our approach is simple: We find the most promising legal minds and we invite them to pursue their careers at S&C. The people to whom we make offers will have many choices and a short window for decision-making, so our partners, associates and recruiting staff across all of our offices are deeply focused on this effort.

What should judicial clerks who are interviewing with S&C expect during the interview process?

Whenever possible, we strongly prefer to meet with candidates in-person, in one of our offices. S&C's approach to our work with clients is highly team-oriented and collaborative. The same is true on the recruiting front. Our interview format provides interested clerks with significant exposure to our lawyers and allows them to see how partners and associates interact and engage with one another. It is our goal to provide a highly personalized interview experience that focuses on the interests and professional goals of each candidate. Ideally, it will be more than

an interview; it will be an opportunity for a meaningful discussion of each clerk's professional aspirations. During each interview, clerks can expect to meet with both partners and associates and often will join our lawyers for lunch or dinner or receptions we host during the clerkship recruiting season.

At the beginning of your career, you clerked on the Second Circuit for The Honorable Lawrence W. Pierce, United States Court of Appeals. Can you tell us how that experience helped to prepare you for success at the Firm?

One of the hallmarks of an experienced S&C lawyer is a breadth of perspective and the ability to work effectively in a range of substantive areas. Although I am principally a deal lawyer, I work on an almost-daily basis with our litigators. The training from my clerkship dovetails exceedingly well with our generalist, multidisciplinary practice. Judge Pierce was an exceptional teacher who not only encouraged me but also challenged me to do my best work. I quickly found many like-minded mentors at the Firm who were invested in my development, and I have taken a similar approach when working with our younger colleagues. The one-on-one mentorship model is alive and well at S&C and judicial clerks thrive here for precisely that reason.

Do you have any final words of advice for judicial clerks who will be interviewing with the Firm?

Do your best to familiarize yourself with S&C, our practice and the work that we do. It's important to give some thought to the generalist multidisciplinary approach and whether this appeals to you as it is central to the way we develop lawyers at the Firm. In addition to some basic advanced preparation, the most important thing you can do is to be authentic. We want to get to know you and for you to get to know us.

A Massive Arbitration Win

When longtime S&C client Bayer faced a multibillion-dollar dispute with BASF, the company turned to litigation partners Dustin Guzior, Steve Holley and Rick Pepperman. The resulting victory before an International Chamber of Commerce tribunal drew industry-wide attention, with *The American Lawyer* honoring the trio as "Litigators of the Week." Dustin was also recently recognized as one of *Law360*'s "Rising Stars" and has been named to the National LGBT Bar Association & Foundation's "Best LGBTQ+ Lawyers Under 40."

Convinced they could present a more compelling case face-to-face, the team persuaded the tribunal to hold in-person proceedings in Frankfurt, Germany at a time when nearly all international arbitrations were being conducted remotely due to COVID-19. After two weeks of hearings, in which 16 fact witnesses and four experts testified, they defeated BASF's claims that Bayer had failed to disclose certain costs when Bayer sold parts of its crops sciences business to BASF for €7.4 billion. In this excerpt from their *American Lawyer* interview, Dustin, Steve and Rick described the experience and explained how their courtroom trial experience gave them an edge in this arbitration forum.



Depositions almost never happen in international arbitration, but we put forward a cogent explanation for why we needed to interview our adversary's employees—and got the interviews. Similarly, our cross-examination style was a bit more pointed and aggressive [than in most arbitrations], but it paid off."

The live hearing also enabled the arbitrators to assess better the witnesses' credibility. The team felt strongly about this point, and the intuition ended up being correct."





With 13 offices worldwide, the Firm is known for handling complex cross-border and multi-jurisdictional disputes. Many nationalities are represented among our bench, including dozens of Canadian lawyers.

"That built-in network is key—in terms of having mentors as you transition to U.S. law, but also from a cultural standpoint," says Kiran.

Marie-Ève agrees, adding, "It's great to have colleagues who understand the Canadian viewpoint available to help shape how you think about U.S. law."

After completing clerkships at the Federal Court of Appeal and the Supreme Court of Canada, Marie-Ève was undecided between practicing in Toronto or New York, until S&C put her in touch with current and former Canadian associates.

"They all spoke about the meaningful work they had done, such as taking on significant responsibility on pro bono matters. Most importantly, they praised what a great community it was," Marie-Ève says.

Kiran, who was a summer associate and clerked at both the Supreme Court of Canada and Court of Appeal for Ontario before re-joining the Firm, noted that her clerkship experience helped her get acclimated quickly as a lawyer in New York.

"As a clerk, I learned the importance of clear and concise legal writing and how to distill complex research, arguments and facts into an accessible format," says Kiran. "That experience has been directly transferable to my day-to-day work as a litigation associate and critical to my growth."

S&C hosts an annual dinner in Ottawa for clerks of the Supreme Court of Canada.

From the U.S. Supreme Court to S&C

Max Gottschall was lucky enough to clerk for three different judges before joining S&C as a litigation associate. Below he shares some of the lessons he's learned and why he chose S&C.

 $What \, made \, you \, decide \, to \, join \, S \\ \mathfrak{S}Cin \, New \, York?$

I had three criteria in my search. First, because I had worked only in D.C., I wanted to work where I'd be exposed to all different kinds of "New York legal market" matters and not be pigeonholed into one or two discrete areas of practice. Second, because of my ties there, I also wanted a firm with a significant presence in Washington. And finally, I wanted to work with the absolute best litigators. Thus, S&C was an easy choice.

What was it like clerking for the Supreme Court?

One thing that's intimidating about clerking on the Supreme Court is that, in even the highestprofile cases, it's just you, your co-clerks and the justice working on it. You learn how to deal with that responsibility, how to summon the necessary confidence and balance it with humility. Those lessons will serve me well in earning our clients' trust.

How has clerking prepared you for your work at SE&C?

Clerking provides a glimpse into how judges decide cases in real time. I was immensely privileged to have that experience with three different judges, each of whom brought their own unique perspectives and approaches. I learned so many lessons on life and lawyering from each of them—too many to recount here.

Developing Through Pro Bono

Pro bono work has been integral to Trevor Chenoweth's associate experience.

In his first month at S&C, he advised on a successful petition to seal the criminal record of a young woman who had pleaded guilty to a nonviolent felony and who faced employment and education obstacles because of her record. Later, acting as a special assistant district attorney, he successfully defended a homicide conviction and 23-year sentence, delivering the oral argument before a four-judge panel.

More recently, Trevor helped defend a criminal case in the U.S. District Court for the Eastern District of New York, which included submitting a petition for certiorari to the Supreme Court. After the defendant pleaded guilty, Trevor helped argue for a fair sentence considering the punishing conditions his client endured in a federal detention center during the height of the COVID-19 pandemic.

"We successfully convinced the judge that our client had endured more than enough imprisonment and that he was now a changed man. He walked into court as a criminal defendant and detainee, and he walked out that same day to rejoin his family with a sentence of time served," Trevor recalled.

Trevor recognizes the connection between his experiences as a clerk and his passion for pro bono work. "There's a significant service component to clerking," he explains. "You feel good about serving the country and the people who rely on the legal system. Working on pro bono cases has allowed me to further justice across both sides of the aisle."

"It's amazing to see what our lawyers go on to do after S&C," says Nicole Weber. As leader of S&C's alumni program and career resource center, Nicole is in touch daily with this talented community. "Some go in-house at startups and banks, others become professors or judges, or switch careers entirely. There's always interest in positions with government agencies, such as the Offices of the United States Attorneys."

A significant number of S&C lawyers are accepted for these prestigious roles. For example, Jessica Ecker, who as an associate was featured in last year's brochure, joined S&C in 2019 following her clerkships. Early on, she expressed interest in being a federal prosecutor. Partner Nic Bourtin (see page 9), who served as an Assistant United States Attorney in the Eastern District of New York from 2001 to 2005, mentored her in her effort to realize this dream. She is now serving as an Assistant United States Attorney in the District of New Jersey.

Similarly, Special Counsel Andrew DiFilippis recently re-joined S&C after nearly a decade as an Assistant United States Attorney in the Southern District of New York. He served as a senior member of the National Security and International Narcotics Unit and routinely briefed the United States Attorney General and other senior Department of Justice officials, and coordinated with the Federal Bureau of Investigation, Central Intelligence Agency, State Department and other parts of the federal government.

Joining a United States Attorneys Office was also a dream for associate Dylan Aluise, who started in the District of Columbia in January. "I've always wanted to be a federal prosecutor," he said. "I know S&C has prepared me well for it."
